**FY2021/2022**

*End Female Genital Mutilation by strengthening coordination in the area of legislation and policy framework, communication and advocacy, evidence generation and support cross border collaboration on elimination of FGM by 2022*

### **Summary of Key Achievements by GoK**

- SDG Award to aFGMB
- Training of resource persons
- facilitating community anti-FGM declarations,
- Facilitating development of county policies in Garissa, Narok, Tana River and Migori counties
- Launching of Sub-County Anti-FGM Steering Committees in 22 FGM hot spot counties
- Convening cross-border community dialogues in 3 border points (Kenya-Tanzania, Kenya-Ethiopia and Kenya-Uganda)
- Partnering with KSG to train 44 Anti-FGM Champions
- convening of a high level global experts meeting on data and research on FGM in Nairobi
- Achievements related to key anti-FGM indicators: 182 cases reported; 482 girls rescued; 81 perpetrators arrested; 377 prosecution cases ongoing; 4,862 girls undergoing Alternative Rights of Passage (ARP)
- Mapping of new partners implementing anti-FGM interventions initiated

### **Summary of Key Contributions of Development Partners, CSOs and Private Sector**

- Training health care providers on combating medicalization of FGM
- 321 healthcare providers in 10 counties trained on GBV medical management and evidence collection
- 6 GBVRCs established in Homabay, Kwale, Kilifi, Makueni, Baringo, and Kisii counties
- 869 GBV survivors supported with court expert witnesses
- Support for the establishment of one TWG and 12 GBV TWGs at both national and county levels
- Advocacy on Gender equality and women's empowerment
- Technical and financial support to AFGMB.
- Implementation of anti-FGM programmes especially targeting children.
- Facilitating community dialogues on review of the Kwale County Sexual and Gender Based Violence Bill that is under discussions at the County Assembly
- Support convening of multi-agency retreats and preparation of presidential report
- Implementation of training curriculum on addressing FGM to anti-FGM champions and resource persons



- Advocacy on Elimination of social and cultural norms: 120 gender champions trained on GBV prevention and response, Human rights and AJS in Kilifi and West Pokot Counties; 60 champions trained on Para legalism and 45 law enforcement officers sensitized on human rights, AJS and ADR; 6,681 community members sensitized on identification, reporting and following up SGBV cases; 78 sexual gender-based violence cases (Early marriage, teen pregnancy, defilement, sexual harassment) were documented and reported in Kilifi and West Pokot Counties; 8 perpetrators were jailed; some cases have been resolved by the children's department while others are ongoing in Kaloleni, Mariakani and Kapenguria law courts.
- Networks established and supported in Kilifi and West Pokot

- FGM is a violation of rights of women and girls
- FGM disempowers women and girls and inhibits their potential contribution to socio-economic development
- FGM is an outlawed in Kenya as a harmful practice
