In 2019, Civil Society Organisations collaborated with the GOK, UNFPA, The Danish government, development partners, local NGOs and other stakeholders to develop the ambitious ICPD25 agenda focused on achieving "3 zeros":

- zero unmet need for Family Planning;
- zero preventable maternal deaths, and
- zero Gender Based Violence and harmful practices against women, girls and youth.

Since then, to achieve these goals, CSOs have continued to collaborate with the GoK, communities, like-minded development partners and stakeholders, to translate clinical and programmatic evidence into policies and guidance documents in ICPD25 focus areas i.e AYSRH, Family planning/Contraception; HIV&AIDS; MCH; Integrated service delivery; Population, Health and Environment/Population, Environment and Development (PED); task sharing and Gender Equality and Equity.

In responding to the 17 GOK ICPD25 commitments, CSOs have drawn on our deep belief in what is possible when communities unite for a common cause; to harness the power of strong public-private sector partnerships/institutions, and support a culture of respectful consultation.

In the interest of time - I will highlight just a few ICPD25 implementation achievements CSOs have provided support to the Government of Kenya.

Several non-state actors support government effort towards gender equality and women's empowerment at policy and programmatic level including legal and social interventions

- Eliminate, by 2030, all forms of gender-based violence, including child and forced marriages, by addressing social and cultural norms that propagate the practice while providing support to women and girls who have been affected.
- The State Department for Gender partnered with local and international CSOs in capacity building (financing and training) and empowerment programs.
- To address gender related discrimination and inequalities:
 - 120 gender champions on GBV prevention and response trained and supported to conduct community forums, identify, report and followup SGBV cases.
 - 5,578 community sensitizations held
- In Kilifi:

45 SGBV cases (child marriage, teen pregnancy, defilement, sexual harassment have been documented and reported from which 9 cases are before court and 4 perpetrators were sent to jail.

In West Pokot

13 SGBV cases (3 defilement cases, 1 FGM circumcisers case, 6 early forced marriage cases and 3 teen pregnancy cases) have been identified, reported and are ongoing at Kapenguria law Courts and cases of neglect being handled by Children's Dept
